1. Registration fees

Body painter & Face painter

- **40,- Euro** per registration for each category

Your participation will not be considered until your registration fee has been paid.
A receipt will be issued immediately.

Upon collecting your accreditation the registration fee for the body painter/face painter will be reimbursed.

The registration fee includes (for body painter/ face painter/assistance/model)

- Set-up work place (table, chairs, sun protection, if necessary wind/ rain protection, and as needed electricity).
- Participance in the competition
- Lunch-box & water

Registration for photographers / Photo ticket:

- **69,- Euro** 1-day pass
- **120,- Euro** 2-day pass

The accordant fee is to be paid immediately. The participation will not be considered until your registration fee has been received. The accreditation will be available on location.

The registration for photographer / photo ticket includes:

- Access to the designated exclusive professional photo area
- Access to the closed off area in front of the stage with best view



2. Prize

- All participants will receive a certificate of participation
- All participants will have access to the Media Data Base to download picture files – for your own reuse

3. Terms of agreement

- Each team is allowed to participate with max 3 person (artist, assistant & model)
- In the category face painting only 2 persons are permitted (artist & model). An assistant is not permitted.
- The number of participating artists is limited.
- The participation is granted on first comes first serves basis according to the date of receipt of the participation fee.
- In case of no-show the participation fee is non-refundable
- With the registration the artist grants non-restrictive right of use of all stills and video footage to the organizer and co-organizers.
- Video footage & stills as well as digital media are not for commercial use without permission of the organizer.
- Copy right is property of the artist
- Every model must wear at least a string tanga. The upper part of the body may be exposed.
- Paintings & decorations for each category should be according to the given theme:

Theme 24th July : World heritage

Theme 25th July: Fantasy

- For the stage presentation each artist needs to bring his/her own music on CD as a WAV-file
- Only CDs are accepted. No other media is permitted
- The music needs to be handed in during accreditation. For each presentation one separate CD is required.
- The maximum length of music is 2 minutes.
